Rowling has captivated tremendous attention from people of all ages all over the world. However, the ones that have probably been most grasped by Harry Potter are the children who started reading the first book of the series when they were between eight and twelve and then grew up with Harry (who turns eleven in the first book). There is a generation of children who were always about the same age as the protagonist of the series. And as Harry got older with every publication of a new book, so did they. There are readers who have read every book of the series, children who have read them multiple times and others who only know one or some of the books. However, according to the survey considered in this paper at least one Harry Potter book has been read by the majority of 18-20-year olds.
